<u>Sub</u>: Postal ballot process under Section 110 of the Companies Act, 2013 ("Act"), read with the Rule 22 of the Companies (Management and Administration) Rules, 2014 ("Rule") — Submission of Scurtiniser's report.

The Board of Directors of your Company has, vide resolutions passed on 21st August, 2018, decided to:

- (a) Conduct a postal ballot process to obtain the approval of your members for adopting new object clause of Memorandum of Association and adopting the new Articles of Association.
- (b) **Provide the** members of your company to send their assent or dissent on the said resolutions in writing on a **Postal Ballot Form**;
- (c) Fix 31st August, 2018 as the cut-off date to determine the members eligible to exercise their votes and the number of votes that can be exercised by such members; and

- 2. Postal ballot facility was made available to the members and the postal ballot notice duly contains the necessary particulars.
- 3. **Postal Ballot notice** was sent on 4th October, 2018 through registered post to members, along with the postal ballot enclosed on self-addressed postage pre-paid envelope.
- 4. The postal ballot notice has also been placed on the Company's website www.kannapiran.co.in and has remained on the website till the last date for receipt of postal ballot forms from the members.

- 5. The postal ballot notice indicates the process and manner for voting by Postal ballot and also mentioned that:
 - (a) The business set out in the notice may also be transacted through Postal Ballot process.
 - (b) **5th November, 2018 (5.00 P.M. IST)** would be the last date and time for ballots to reach the Scrutiniser.
- 6. The Company **published advertisements** about having sent the postal ballot notice on **6th October**, **2018** in the following newspapers, having wide circulation in Coimbatore District in which the registered office of the Company is situated.
 - (a) "Trinity Mirror" an English newspaper in English language; and
 - (b) "Makkal Kural" a Tamil newspaper in Tamil language (Coimbatore edition).
- 7. The postal ballot forms received were opened in my presence and scrutinised.
- 8. After 5.00 p.m. on 5th November, 2018, I have finalised the votes in the presence of two witnesses not in the employment of the company.
- 9. I have:
 - (i) Scrutinised all the **postal ballot forms received** from the members of the company **upto 5.00** p.m. on 5th November, 2018
 - (ii) Not received any postal forms after 5.00 p.m. on 5th November, 2018.
 - (iii) Not received any mutilated ballot papers.
 - (iv) Considered one (1) ballot for 192 shares as rejected due to in correct way of placing the tick mark in the ballot form.
 - (v) Matched / confirmed the shareholding as stated in the postal ballot forms with that mentioned in the Register of Members as on cut-off date.
 - (vi) Recorded the details in a separate register maintained for the purpose.
